In accordance with their responsibilities in Article XI (Entry into Effect, Amendment, and Termination), the Department of Defense of the United States of America and the Ministry of Defence of the United Kingdom of Great Britain and Northern Ireland have mutually agreed to amend the Memorandum of Understanding Between the Department of Defense of the United States of America and the Ministry of Defence the United Kingdom of Great Britain and Northern Ireland for the Loan of Thermal Weapons Sights (TWS) for Concept Evaluation (A-LOAN-UK-2005-0060), signed May 25, 2006 as follows:

- 1.1. Section I (Description and Quantity), subparagraph 1.3. is amended to read as follows:
 - 1.3. The loan period is for 360 days after signature of this MOU, unless the latter date is extended pursuant to paragraph 11.2. In the event that this MOU is terminated prior to expiration of the loan period, paragraph 3.4.6. applies.
- 1.2. Section XI (Entry into Effect, Amendment, and Termination), subparagraph 11.5., is amended to read as follows:
 - 11.5. This MOU will enter into effect on the date of the later signature below, and unless terminated or extended, will remain in effect for thirty-six (36) months.
- 1.4. All other provisions of the MOU remain unchanged.
- 1.5. This amendment will enter into effect upon the signature of the Participants.


