
The Embassy of the United States of America proposes that the aforementioned 2003 exchange of notes, in accordance with paragraph 5 thereof, be renewed for an additional period of two years effective March 5, 2007. The aforementioned 2003 exchange of notes shall continue to be renewable upon mutual consent through an exchange of notes. In the event that the aforementioned 2003 exchange of notes, as renewed is not renewed

after that period, its provisions shall continue to apply to any act occurring, or any allegations arising, while that exchange of notes, as renewed, was in force. If the proposal set forth herein is acceptable to the Government of the Arab Republic of Egypt, this note and the Ministry's affirmative note in reply shall constitute binding obligations under international law from the date of the Ministry's note in reply with effect from March 5, 2007.
