**AMENDMENT NO. 2.**

**STRATEGIC OBJECTIVE GRANT AGREEMENT**

AMENDMENT NUMBER TWO TO THE STRATEGIC OBJECTIVE GRANT AGREEMENT between the Government of the United States of America, acting through the United States Agency for International Development (USAID), and the Government of the Islamic Republic of Afghanistan, acting through the Ministry of Finance (hereinafter referred to as the "Grantee"), dated as of April 6, 2006.

WHEREAS, The Grantee and USAID entered into a Strategic Objective Grant Agreement ("SOAG") for the strategic objective of a thriving economy led by the private sector, USAID Grant Agreement No. SOAG-306-05-00 dated September 19, 2005 (capitalized terms not defined in this amendment shall have the meanings ascribed thereto in the SOAG) and subsequently amended such agreement on September 30, 2005 (Amendment No. 1); and

WHEREAS, USAID and the Grantee wish to amend Section 3.1 (a) of the SOAG to increase the USAID contribution by FIFTY MILLION SIX HUNDRED SIXTY TWO THOUSAND (US) DOLLARS (US\$50,662,000.00);

Therefore Section 3.1(a) of the SOAG is amended as follows:


- (a) Section 3.1 (a) is amended by deleting the amount TWO HUNDRED NINETY TWO MILLION TWO HUNDRED EIGHTY THOUSAND ONE HUNDRED TWENTY EIGHT AND EIGHTY TWO HUNDRETHS United States ("U.S.") Dollars (\$292,280,128.82) and inserting the amount THREE HUNDRED FOURTY TWO MILLION NINE HUNDRED FOURTY-TWO THOUSAND ONE HUNDRED TWENTY-EIGHT AND EIGHTY-TWO HUNDRETHS (U.S.) DOLLARS (US\$342,942,128.82) in lieu thereof.

All other terms and conditions of the SOAG remain unchanged and in full force and effect. This Amendment is prepared in both English and Dari. In the event of ambiguity or conflict between the two versions, the English language version will control.


