

AMENDMENT ONE TO THE  
ACQUISITION AND CROSS-SERVICING AGREEMENT  
BETWEEN  
THE MINISTRY OF NATIONAL DEFENSE  
OF THE REPUBLIC OF POLAND  
AND  
THE DEPARTMENT OF DEFENSE  
OF THE UNITED STATES OF AMERICA

The Parties to the Acquisition and Cross-Servicing Agreement between the Department of Defense of the United States of America and the Ministry of National Defense of the Republic of Poland, signed at Warsaw on 22 November 1996, agree to amend said agreement as follows:

1. Article II, paragraph 4(2): Change the parenthetical phrase to read, "(except for the lease or loan of general purpose vehicles and other nonlethal items of military equipment which are not designated as significant military equipment on the United States Munitions List)".
2. Article III, paragraph 1(1): Change the last sentence to read, "Such term also includes the temporary use of general purpose vehicles and other nonlethal items of military equipment which are not designated as significant military equipment on the United States Munitions List."
3. Article IV, paragraph 4: Change the last sentence to read, "When operations are conducted outside EUCOM or with U.S. forces from another Unified Command, EUCOM may authorize the other Unified Command to negotiate one or more Implementing Arrangements covering those operations, or the respective EUCOM Service Components will assist in processing the requirement with the Republic of Poland."
4. Article IV, paragraph 6: Change the penultimate sentence to read, "In the case of the United States, these notifications shall go directly to the United States party to the Implementing Arrangement with a copy to EUCOM, ATTN: ECJ4-ML."
5. Article V, paragraph 1.(1): Change "within 30 days" to "within 90 days".
6. Change the designation "(US-PO-01)" to read "(US-PL-01)" wherever it appears in the Agreement.

This Amendment shall enter into force on the date of the last signature affixed below.

This agreement is signed in four (4) originals, two in the Polish language and two in the English language, all texts being equally authentic.


