## PREAMBLE

The purpose of Amendment 2 to the Memorandum of Understanding (MOU) Concerning Production, Remanufacture, and In-Service Support for the AV-8B Harrier II Plus Program is to extend the duration of the MOU only for the purposes of accommodating delivery of certain aircraft and other items and for completing contract close-out procedures, including final payment, associated with the provision of such items.

Accordingly, the Participants have agreed as follows:

## SECTION I

### AMENDMENT

1. The MOU is hereby amended as follows:

In SECTION II: SCOPE OF WORK, delete current paragraph 3 and substitute therefor the following new paragraph 3:

"3. After 31 December 2002, efforts undertaken by the Participants under this MOU shall be limited solely to those necessary to accomplish provision of, and contract close-out procedures for, the following:

- a. Not more than seven (7) remanufactured aircraft, including Integrated Logistic Support (ILS) and spares associated with these remanufactured aircraft, scheduled for delivery to Spain by 30 June 2004.
- b. Any deliverables, under contracts entered into under this MOU, for which the original estimated delivery date is 31 December 2002 or earlier."

2. In SECTION VI: EFFECTIVE DATE AND SIGNATURES, delete the words "until 30 June 2004" in the last sentence, and replace with "until 31 December 2006."


3. All other provisions of this MOU remain unchanged.


