



This AMENDMENT No. 3 is entered into between the REPUBLIC OF INDONESIA ("Grantee") and the UNITED STATES OF AMERICA, acting through the U.S. AGENCY FOR INTERNATIONAL DEVELOPMENT ("USAID").

WHEREAS, the Grantee and USAID (together "the Parties") entered into a Strategic Objective Grant Agreement for Economic Growth ("Grant Agreement") on August 31, 2000, as amended on September 28, 2000 and July 21, 2001 and whereby USAID agreed to grant to the Grantee an amount not to exceed Twenty Nine Million Five Hundred and Twenty One Thousand Seven Hundred and Seven United States Dollars (\$29,521,707).

WHEREAS, the Parties now desire to further amend the Grant Agreement to provide an additional increment of USAID financing in the amount of Twelve Million Five Hundred Seventy Seven Thousand United States Dollars (\$12,577,000);

NOW, THEREFORE, the Grantee and USAID hereby agree as follows:

1. Section 3.1 (a) of the Grant Agreement is revised to read as follows:

"SECTION 3.1.(a) The Grant. To help achieve the Objective set forth in this Agreement, USAID, pursuant to the Foreign Assistance Act of 1961, as amended, hereby grants to the Grantee under the terms of this Agreement not to exceed Forty Two Million Ninety Eight Thousand and Seven Hundred and Seven United States ("U.S.") Dollars (\$42,098,707).


2. "Table 1, Revised Financial Plan (July 2001)" is deleted in its entirety and "Table 1, Revised Financial Plan (September 2001)" is substituted in lieu thereof.

Except as amended herein, the Grant Agreement, as amended, is unchanged and remains in full force and effect.


