

**AMENDMENT NUMBER TEN TO THE
STRATEGIC OBJECTIVE GRANT AGREEMENT**

BETWEEN

**The United Republic of Tanzania, represented by
The Ministry of Finance (the "GOT")**

AND

**The United States of America, acting through
The United States Agency for International Development ("USAID")**

This is Amendment Number Ten to the Strategic Objective Grant Agreement for Strategic Objective 10, Enhanced Multisectoral Response to HIV/AIDS, dated June 7, 2005 (as amended, the "Agreement"), between USAID and the GOT (together, the "Parties"), as amended by the Parties through amendment Number One on September 26, 2005, amendment Number Two on March 20, 2006, amendment Number Three on May 6, 2006, amendment Number Four on September 25, 2006, amendment Number Five on March 01, 2007, Amendment Number Six on May 03, 2007, Amendment Number Seven on July 11, 2007, Amendment Number Eight on September 26, 2007 and Amendment Number Nine on May 08, 2008.

WHEREAS, the Parties hereto desire to make amendment to the Agreement by increasing the USAID grant by an additional increment of Ninety Three Million, Seven Hundred Thousand, Six Forty Five U.S. Dollars (\$93,700,645) for the purpose of providing additional funding for HIV/AIDS prevention, treatment and care activities, and aligning the budget consistent therewith;

NOW THEREFORE, the Agreement is hereby amended as follows:

1. Article 3: Contribution of Parties, Section 3.1 (a) is deleted in its entirety and replaced by the following:

“(a) The Grant. To help achieve the Objectives set forth in the Agreement, USAID, pursuant to the Foreign Assistance Act of 1961, as amended, hereby grants to the GOT under the terms of this Agreement, as amended, an amount not to exceed Two Hundred Seventeen Million, Forty Five Thousand, Eight Hundred Ninety Three U.S. Dollars (\$217,045,893) for the purpose of providing funding for HIV/AIDS prevention, treatment and care activities.

2. Article 3: Contribution of Parties, Section 3.1 (b), is deleted in its entirety and replaced by the following:

“(b) Total Estimated USAID Contribution. The total estimated contribution of USAID under this Agreement is expected to be Five Hundred Sixty Seven Million U.S. Dollars (\$567,000,000), which is to be

provided in incremental funding. Of this sum, Two Hundred Ninety Two Million, Six Thousand, Eight Hundred Seventy One U.S. Dollars (\$292,006,871) has been contributed to date, of which Two Hundred Seventeen Million, Forty Five Thousand, Eight Hundred Ninety Three U.S. Dollars (\$217,045,893) have been granted directly to the United Republic of Tanzania under this Agreement; and Seventy Four Million, Nine Hundred Sixty Thousand, Nine Hundred Seventy Eight U.S. Dollars (\$74,960,978) has been obligated by USAID/Washington, directly into grants or contracts to carry out activities in Tanzania in furtherance of the objective under this Agreement. Subsequent increments are subject to the availability of funds to USAID for this purpose and the mutual agreement of the Parties, at the time of each subsequent increment, to proceed.”

3. Annex 1, the Strategic Objective 621-0010.01-09 Illustrative Financial Plan, is deleted in its entirety and the attached Tenth Amendment Illustrative Financial Plan, (Attachment A hereto), is substituted therefor.

4. Except as amended herein, all other terms and conditions of the Agreement remain in full force and effect.

IN WITNESS WHEREOF, the United States of America and the Government of the United Republic of Tanzania, each acting through its respective duly authorized representatives, have caused this Amendment Number Ten to be made effective as of the day and year first written above.




