AMENDMENT NUMBER NINE TO THE STRATEGIC OBJECTIVE GRANT AGREEMENT between the Government of the United States of America, acting through the United States Agency for International Development ("USAID"), and the Government of Pakistan, acting through the Economic Affairs Division of the Ministry of Economic Affairs and Statistics ("GOP" or "Grantee").

WHEREAS, the GOP and USAID entered into a Strategic Objective Grant Agreement for Health and Population Welfare, Grant Agreement No. 391-007, dated August 18, 2003, as subsequently amended (the "Agreement").

WHEREAS, USAID and the Grantee wish to further amend the Agreement to increase the USAID contribution by US\$76,520,386, for a total amount of US\$242,206,848.

NOW THEREFORE, the parties to the Agreement hereby agree as follows:

A. USAID Contribution:

1. **The Grant.** Section 3.1(a) of the Agreement is amended by deleting the amount of "One Hundred Sixty-Five Million, Six Hundred Eighty-Six Thousand, Four Hundred Sixty-Two U.S. Dollars (US\$165,686,462)" and inserting the amount "Two Hundred Forty-Two Million, Two Hundred Six Thousand, Eight Hundred Forty-Eight U.S. Dollars (US\$242,206,848)" in lieu thereof.

2. **Total Estimated USAID Contribution.** Section 3.1(b) of the Agreement is amended by deleting the amount of "One Hundred Seventy-Five Million, Four Hundred Ninety-Eight Thousand, Four Hundred Eight U.S. Dollars (US\$175,498,408)" and inserting the amount of "Two Hundred Fifty-Four Million, Eighteen Thousand, Seven Hundred Ninety-Four U.S. Dollars (US\$254,018,794)" in lieu thereof.

B. Illustrative Financial Plan, Annex 1, Amplified Description: The Illustrative Financial Plan in Section III, Funding, of Annex 1, Amplified Description of the Agreement, as amended, is hereby deleted in its entirety and replaced by the Illustrative Financial Plan attached hereto as Attachment A.


C. Other Terms and Conditions: All other terms and conditions of the Agreement remain unchanged and in full force and effect.

*Out of \$85.02 million FY 2008 funds, \$6.500 million have been obligated through Health and Population Welfare SOAG Amendment Number 8, signed between United States Government and the Government of Pakistan on August 15, 2008 and \$2 million will be obligated by USAID/Washington for infectious disease control programs through a Washington-based "field support" mechanism. This SOAG Amendment Number Nine obligates remaining FY 2008 funds of \$76.52 million.

Changes may be made to the Financial Plan by representatives of the Parties without formal amendment to the Agreement, if such changes do not cause USAID's contribution to exceed the amount specified in Section 3.1 of the Agreement, or the Grantee's contribution to be less than the amount specified in Section 3.2 of the Agreement.
