

**AMENDMENT NUMBER TEN TO THE  
STRATEGIC OBJECTIVE GRANT AGREEMENT**

**BETWEEN**

**The United Republic of Tanzania, represented by the  
Ministry of Finance and Economic Affairs (“GOT”)**

**AND**

**The United States of America, acting through  
The United States Agency for International Development (“USAID”)**

This is Amendment Number Ten to the Strategic Objective Grant Agreement for Strategic Objective 11, Health Status of Tanzania Families Improved dated August 23, 2005 (as amended, the “Agreement”), between USAID and the GOT (“the Parties”) as amended by the Parties through Amendment Number One on May 23, 2006, Amendment Number Two on August 2, 2006, Amendment Number Three of August 24, 2007, Amendment Number Four on September 11, 2007, Amendment Number Five on March 27, 2008, Amendment Number Six on April 30<sup>th</sup>, 2008, Amendment Number Seven on August 15<sup>th</sup>, 2008, Amendment Number Eight on December 22, 2008, and Amendment Number Nine on April 8, 2009.

WHEREAS, the Parties hereto desire to make amendment to the Agreement by: 1) obligating Thirty Six Million, Seven Hundred and Seventy One Thousand, Eight Hundred and Fifty Eight U.S. Dollars (\$36,771,858) in incremental grant funding; (2) adding Nine Million, Nine Hundred and Fifty Two Thousand, Four Hundred and Forty Two U.S. Dollars (\$ 9,952,442) in additional support which has been obligated through field support by USAID/Washington into grants or contracts to carry out activities in Tanzania in furtherance of the objectives under this Agreement; (3) increasing the Estimated Life of Agreement Funding by Forty Six Million, Seven Hundred and Twenty Four Thousand, Three Hundred U.S. Dollars (\$46,724,300), from One Hundred and Forty Nine Million, Three Hundred and Sixty Four Thousand, Nine Hundred and Fourteen U.S. Dollars (\$149,364,914) to One Hundred and Ninety Six Million, Eighty Nine Thousand, Two Hundred and Fourteen U.S. Dollars (196,089,214); and (4) amending the Illustrative Financial Plan for the purposes of supporting malaria control activities, family planning and reproductive health activities, maternal and child health activities, and infectious disease activities (including avian influenza).

NOW THEREFORE, the Agreement is hereby amended as follows:

2. Article 3, Section 3.1, paragraph (a), "The Grant" is hereby deleted in its entirety and replaced by the following:

"(a) The Grant. To help achieve the Objective and Results set forth in this Agreement, USAID, pursuant to the Foreign Assistance Act of 1961, as amended, hereby grants to the GOT under the terms of this agreement, as amended, an amount not to exceed One Hundred and Twenty One Million, Six Hundred and Six Thousand, Nine Hundred and Seventy Four U.S. Dollars (\$121,606,974) (the "Grant"), of which amount no less than Eighty Million, Ninety Seven Thousand, Three Hundred and Sixty Three U.S. Dollars (\$ 80,097,363) shall support Malaria Control; no less than Twenty Seven Million, Eight Hundred and Forty One Thousand, Three Hundred and Seventy Six U.S. Dollars (\$27,841,376) shall support Family Planning and Reproductive Health activities; no less than Twelve Million, Nine Hundred and Twenty Two Thousand, Two Hundred and Thirty Five U.S. Dollars (\$12,922,235) shall support Maternal and Child Health activities; and no less than Seven Hundred and Forty Six Thousand U.S. Dollars (\$746,000) will support Infectious Disease activities."

- Article 3, Section 3.1 paragraph (b), "Total Estimated Contribution" is hereby deleted in its entirety and replaced by the following:

"(b) Total Estimated USAID Contribution. USAID's total estimated contribution to achievement of the Objective shall be One Hundred Ninety Six Million, Eighty Nine Thousand, Two Hundred and Fourteen U.S. Dollars (\$196,089,214) which is to be provided in increments. Of this sum One Hundred Ninety Six Million, Eighty Nine Thousand, Two Hundred and Fourteen U.S. Dollars (\$196,089,214) has been contributed to date; of this amount, One Hundred and Twenty One Million, Six Hundred and Six Thousand, Nine Hundred and Seventy Four U.S. Dollars (\$121,606,974) has been granted directly under this Agreement; Fourteen Million, One Hundred and Twenty One Thousand, Nine Hundred and Seventy Five U.S. Dollars (\$14,121,975) has been obligated by USAID/Tanzania directly into grants or contracts, to carry out activities in Tanzania in furtherance of the objectives under this Agreement; and Sixty Million, Three Hundred and Sixty Thousand, Two Hundred and Sixty Five U.S. Dollars (\$60,360,265) has been obligated by USAID/Washington, directly into grants or contracts, to carry out activities in Tanzania in furtherance of the objectives under this Agreement. Subsequent increments are subject to the availability of funds to USAID for this purpose and the mutual agreement of the Parties, at the time each subsequent increment, to proceed."

2. The Strategic Objective Grant Agreement 621-0011.01-09 Illustrative Budget is hereby deleted in its entirety and replaced with a new Annex 1 "Annex 1 Illustrative Budget", which is attached hereto.


3. Except as amended herein, all other terms and conditions of the Strategic Objective Grant Agreement, as amended, remain in full force and effect in accordance with its terms.


