

Sixth Amendment, dated 27 JUN 2010 to the Assistance Agreement, between the Arab Republic of Egypt ("A.R.E." or "Grantee") and the United States of America, acting through the United States Agency for International Development ("USAID")(collectively, the "Parties"), for the Development Support Program II, as last amended on September 29, 2009.

SECTION 1. The Agreement is hereby amended as follows:

A. Article 3, Section 3.1 is amended by deleting "One Billion Sixty Eight Million Two Hundred Thousand United States ("U.S.") Dollars (\$1,068,200,000)" and substituting "One Billion One Hundred and Fifty One Million Two Hundred Thousand United States ("U.S.") Dollars (\$1,151,800,000)" therefor.

B. The Illustrative Financial Plan set forth in Annex I (Amplified Description) to the Assistance Agreement is amended and restated in its entirety, attached hereto.

SECTION 2. Language of Amendment. This Sixth Amendment is prepared in both English and Arabic. In the event of ambiguity or conflict between the two versions, the English language version will prevail.

SECTION 3. Entire Agreement. Except as specifically amended or modified herein, the Assistance Agreement as amended shall remain in full force

and effect in accordance with all of its terms.

SECTION 4. Effectiveness. This Sixth Amendment shall enter into force when signed by both Parties hereto.

SECTION 5. Ratification. The A.R.E. will take all necessary action to complete all legal procedures necessary for ratification of this Sixth Amendment and will notify USAID as promptly as possible of the fact of such ratification.

IN WITNESS WHEREOF, the A.R.E. and the USAID, each acting through its respective duly authorized representative, have caused this Amendment to be signed in their names and delivered as of the day and year first above written.


