Twenty-Fifth Amendment to the Strategic Objective Grant Agreement for A Thriving Economy Led by the Private Sector between the Government of the United States of America, acting through the United States Agency for International Development (“USAID”) and the Government of the Islamic Republic of Afghanistan (“the Grantee”) (collectively, the “Parties”) dated September 19, 2005, as amended (“the Agreement”).

SECTION A: This Twenty-Fifth Amendment hereby amends the Agreement as follows:

1. Article 3, Section 3.1(a) (“the Grant”) of the Agreement is hereby amended by deleting “Four Billion One Hundred Seventy-Seven Million Five Hundred Seventy-Nine Thousand Nine Hundred Forty-Four and Eighty-Two Hundredth United States (“U.S.”) Dollars (\$4,177,579,944.82)” and substituting in lieu thereof “Four Billion Six Hundred Ninety-Eight Million Six Hundred Thirty-Five Thousand Nine Hundred Forty-Four and Eighty-Two Hundredth United States (“U.S.”) Dollars (\$4,698,635,944.82).”

2. Article 3, Section 3.1(b) (Total Estimated USAID Contribution) is hereby amended by deleting “Four Billion One Hundred Seventy-Seven Million Five Hundred Seventy-Nine Thousand Nine Hundred Forty-Four and Eighty-Two Hundredth United States (“U.S.”) Dollars (\$4,177,579,944.82)” and substituting in lieu thereof “Four Billion Six Hundred Ninety-Eight Million Six Hundred Thirty-Five Thousand Nine Hundred Forty-Four and Eighty-Two Hundredth United States (“U.S.”) Dollars (\$4,698,635,944.82).”

3. Article 4 (Completion Date)

Section 4(a) is amended by deleting “December 31, 2011” and substituting in lieu thereof “December 31, 2012.”

4. The Attachment (Illustrative Financial Plan) to Annex I (Amplified Description) of the Agreement is deleted in its entirety and the attached Attachment to Annex 1 is substituted in lieu thereof.

SECTION B. Counterpart Original. This Twenty-Fifth Amendment is prepared and signed in duplicate, each of which shall be deemed to be a counterpart original.


SECTION C. Effectiveness: This Twenty-Fifth Amendment is effective upon the date of signature by the Parties.

SECTION D: This Twenty-Fifth Amendment is prepared in both English and Dari. In the event of a conflict or ambiguity between the two, the English version will control.


SECTION E: Except as specifically amended or modified herein, the Agreement remains in full force and effect in accordance with all of its terms.
