



Amendment No. 6
Assistance Agreement No. 669-AA-A11-07-02

Between the United States of America and the Republic of Liberia
 For Investing in People: Health

1. Purpose of the Amendment

The Assistance Agreement for Investing in People: Health (the "Agreement") dated September 28, 2007, between the United States of America, acting through the United States Agency for International Development ("USAID") and the Republic of Liberia (the "Grantee") (hereinafter, collectively, the "Parties") amended on September 12, 2008, on September 26, 2008, on August 21 2009, on September 30, 2009, and on December 3, 2009, is hereby amended to provide additional funds in the amount of THIRTY MILLION NINETY NINE THOUSAND FOUR HUNDRED AND SEVENTY EIGHT United States Dollars (\$30,099,478.), increase the Total Estimated USAID Contribution from SEVENTY THREE MILLION NINE HUNDRED SIXTY SEVEN THOUSAND FIVE HUNDRED AND SIXTY EIGHT United States Dollars (\$73,967,568), to ONE HUNDRED AND TWENTY SEVEN MILLION NINE HUNDRED AND FORTY EIGHT THOUSAND FORTY SIX United States Dollars (\$127,948,046) and to make other changes as stated below:

2. Financing

Delete paragraph (a) of Article 3, Section 3.1: "USAID Contribution" in its entirety and substitute the following paragraph in lieu thereof:

(a) The Grant. To help achieve the objective set forth in the Agreement, USAID, pursuant to the Foreign Assistance Act of 1961, as amended, hereby grants to the Grantee under the terms of the Agreement an amount not to exceed EIGHTY SIX MILLION FOUR HUNDRED AND FORTY EIGHT THOUSAND FORTY SIX United States Dollars (86,448,046). In addition to funds obligated under this Agreement, SIXTEEN MILLION NINE HUNDRED THOUSAND FIVE HUNDRED AND TWENTY TWO United States Dollars (\$16,900,522) will be obligated by USAID/Washington for activities that support the Objective of this Agreement.

Delete paragraph (b) of Article 3, Section 3.1: "Total Estimated USAID Contribution" and substitute the following paragraph in lieu thereof:

(b) Total Estimated USAID Contribution. USAID's total estimated contribution under the Agreement to achievement of the Objective will be ONE HUNDRED AND TWENTY SEVEN MILLION NINE HUNDRED AND FORTY EIGHT THOUSAND FORTY SIX United States Dollars (\$127,948,046) which will be provided in increments. Subsequent increments will be subject to the availability of funds to USAID for this purpose and may be provided by USAID upon written notice to the Grantee. The Parties agree that each such incremental contribution provided, if any, shall cumulatively increase the total amount of the Grant set forth in Section 3.1 and consequently may increase the Grantee's contribution under Section 3.2. The Grantee

further agrees to acknowledge by written notice to USAID each such incremental contribution, if any.

3. Illustrative Financial Plan

The Budget and Financial Plan included as Attachment 2 to Amendment No. 5, to the Agreement, should be deleted in its entirety and replaced by a revised Attachment 2 to this Amendment No. 6: See Attachment 2 attached hereto – Investing in People Objective – Health Program.

4. Other Terms and Conditions

Except as further amended hereby, all other terms and conditions in the Agreement, as amended, remain in full force and effect.


