



**Amendment No. 5**  
**Assistance Agreement No. 669-AA-A12-07-03-05**

Between the United States of America and the Republic of Liberia  
 For Investing in People: Education

1. Purpose of the Amendment

The Assistance Agreement for Investing in People: Education (the "Agreement") dated September 28, 2007, between the United States of America, acting through the United States Agency for International Development ("USAID") and the Republic of Liberia (the "Grantee") (hereinafter, collectively, the "Parties") amended on September 12, 2008, on August 21, 2009, on December 3, 2009 and on September 17, 2010, is hereby amended to provide additional funds in the amount of THIRTY TWO MILLION United States Dollars (\$32,000,000) and to make other changes as stated below:

2. Financing

Delete paragraph (a) of Article 3, Section 3.1: "USAID Contribution" in its entirety and substitute the following paragraph in lieu thereof:

(a) **The Grant.** To help achieve the Objective set forth in the Agreement, USAID, pursuant to the Foreign Assistance Act of 1961, as amended, hereby grants to the Grantee under the terms of the Agreement an amount not to exceed ONE HUNDRED AND TWENTY FOUR MILLION SEVEN HUNDRED FIFTY ONE THOUSAND EIGHT HUNDRED AND FIFTY SEVEN United States Dollars (\$124,751,857).

Delete paragraph (b) of Article 3, Section 3.1: "Total Estimated USAID Contribution" and substitute the following paragraph in lieu thereof:

(b) **Total Estimated USAID Contribution.** USAID's total estimated contribution to achievement of the Objective will be, ONE HUNDRED AND TWENTY FOUR MILLION SEVEN HUNDRED AND FIFTY ONE THOUSAND EIGHT HUNDRED AND FIFTY SEVEN United States Dollars (\$124,751,857).

3. Illustrative Financial Plan

The Budget and Financial Plan included as Attachment 3, to Amendment No.4, to the Agreement, should be deleted in its entirety and replaced by a revised Attachment 3 to this Amendment No. 5: See Attachment 3 attached hereto – Investing in People Objective – Education Program.

4. Other Terms and Conditions

Except as further amended hereby, all other terms and conditions in the Agreement, as amended, remain in full force and effect.

As highlighted in Section 3.2(b) of the original Assistance Agreement dated September 28, 2007:

The Republic of Liberia's ("Grantee") contribution, based on USAID's contribution in Section 3.1(a) will not be less than the equivalent of one-third of the portion of the Grant that is used to support activities that either directly provides substantial benefit to the Government of the Republic of Liberia or involves a direct and substantial involvement of the Government of the Republic of Liberia in the administration, control or management of such assistance, provided that such amount may be reduced with the written consent of USAID. The Grantee's contribution may include either cash or in-kind contributions or both.
