TWENTY FIFTH AMENDMENT TO THE DEVELOPMENT ASSISTANCE GRANT

AGREEMENT NO. 615-003

Between

The United States of America, acting through the  
United States Agency for International Development ("USAID")

And

The Republic of Kenya (hereinafter referred to as the "GOK" or "Grantee")

**Article 1: Purpose of Amendment**

The purpose of this Twenty Fifth Amendment is to: 1) grant additional USAID resources; and 2) increase the current "in-kind" contribution of the Grantee.

This Twenty Fifth Amendment to the Development Assistance Grant Agreement No. 615-003 dated the 19th day of August 2003, is hereby entered into between the parties above named as follows:

**Article 2: Contributions of the Parties**

Section 3.1 USAID Contribution.

Section 3.1 (a) is deleted in its entirety and replaced with the following:

(a) The Grant: To help achieve the Objective and Results set forth in this Agreement, USAID, pursuant to the Foreign Assistance Act of 1961, as amended, has previously obligated the sum of One Billion, Five Hundred and Eight Million, Seven Hundred and Eighty-Eight Thousand, Seven Hundred and Thirteen U.S. Dollars (\$1,508,788,713). In order to further help achieve the Objective and Results set forth in this Agreement, USAID hereby further grants to the Grantee under the terms of this Agreement an additional amount not to exceed Three Hundred and Three Million, and Eighty-Seven Thousand, Eight Hundred and Sixty-Four U.S. Dollars (\$303,087,864) via this Twenty-Fifth Amendment. This funding through the Twenty-Fifth Amendment shall be used for activities to support USAID Program Area Health: Program Elements HIV/AIDS (\$260,690,394), Tuberculosis (\$3,662,000), Malaria (\$12,651,000) Maternal and Child Health (\$5,680,081), Family Planning & Reproductive Health (\$16,397,000), and Nutrition (\$2,494,000); and Program Area Program Element Administration and Oversight

(\$1,513,389). The total amount of the Grant is now One Billion, Eight Hundred and Eleven Million, Eight Hundred and Seventy-Six Thousand, Five Hundred and Seventy-Seven U.S. Dollars (\$1,811,876,577).

Section 3.2 The Grantee Contribution

Section 3.2 (a) is deleted in its entirety and replaced with the following:

(a) The Grantee contribution for the Strategic Objective under this Twenty-Fifth Amendment is equivalent to One Hundred and One Million, and Twenty-Nine Thousand, Two Hundred and Seventy-Eight U.S. Dollars (\$101,029,278) making the total contribution to date Five Hundred and Thirty Million, Seven Hundred and Eleven Thousand, Four Hundred and Ninety-Seven U.S. Dollars (\$530,711,497). All contributions will be on an "in-kind" basis.

**Article 3: Attachments**

Attachment 1 to Annex 1, Illustrative Budget, Amendment 24 is hereby deleted and Attachment 1 to Annex 1, Illustrative Budget, Amendment 25 is substituted in its stead.

**Article 4: Other Terms and Conditions**

All other terms and conditions of the original Development Assistance Grant Agreement as amended shall remain in full force and effect.
