The Department of Defence of Australia, the Department of National Defence of Canada, the Ministry of Defense of the Republic of Finland, the Ministry of Defense of the State of Kuwait, the Ministry of Defence of Malaysia, the Ministry of Defense of the Kingdom of Spain, the Federal Department of Defense, Civil Protection and Sports of the Swiss Confederation, and the Department of Defense of the United States of America (U.S. DoD), hereinafter referred to as the "Participants":

Having considered the Memorandum of Understanding among the Department of Defence of Australia, the Department of National Defence of Canada, the Ministry of Defense of the Republic of Finland, the Ministry of Defense of the State of Kuwait, the Ministry of Defense of the Kingdom of Spain, the Federal Department of Defense, Civil Protection and Sports of the Swiss Confederation, and the Department of Defense of the United States of America (U.S. DoD) Concerning the Cooperative Framework for the F/A-18 Program (F/A-18 Framework MOU), which entered into effect September 23, 2005,

Have reached the following understandings:




