

**AMENDMENT NUMBER THIRTEEN TO THE
STRATEGIC OBJECTIVE GRANT AGREEMENT
BETWEEN**

**The United Republic of Tanzania, represented by the
Ministry of Finance (“GOT”)**

AND

**The United States of America, acting through
The United States Agency for International Development (“USAID”)**

This is Amendment Number Thirteen to the Strategic Objective Grant Agreement for Strategic Objective 11, Health Status of Tanzanian Families Improved dated August 23, 2005 (as amended, the “Agreement”), between USAID and the GOT (“the Parties”) as amended by the Parties through Amendment Number One on May 23, 2006, Amendment Number Two on August 2, 2006, Amendment Number Three of August 24, 2007, Amendment Number Four on September 11, 2007, Amendment Number Five on March 27, 2008, Amendment Number Six on April 30, 2008, Amendment Number Seven on August 15, 2008, Amendment Number Eight on December 22, 2008, Amendment Number Nine on April 8, 2009, Amendment Number Ten on September 10, 2009, Amendment Number Eleven on August 23, 2010 and Amendment Number Twelve on September 29, 2011.

WHEREAS, the Parties hereto desire to make an amendment to the Agreement by: (1) funding the USAID grant by an additional increment of Seventy-Eight Million, Fifty Five Thousand, Six Hundred Forty Nine United States (“U.S”) Dollars (\$78,055,649) (2) funding Twenty-Six Million, One Hundred Sixty-Four Thousand, Nine Hundred Six U.S. Dollars (\$26,164,906) in additional support, which has been obligated outside of this Agreement by USAID/Tanzania and through field support by USAID/Washington into grants or contracts to carry out activities in Tanzania in furtherance of the objectives under this Agreement; (3) increasing the Estimated Life of Agreement Funding by One Hundred Four Million, Two Hundred Twenty Thousand, Five Hundred Fifty Five U.S. Dollars (\$104,220,555) to Four Hundred Seventy-One Million, Five Hundred Seventy Six Thousand, Six Hundred Seventy Six U.S. Dollars (\$471,576,676); and (4) amending the Illustrative Financial Plan for the purposes of supporting malaria control activities,

family planning and reproductive health activities, maternal and child health activities, and infectious disease activities.

NOW THEREFORE, the Agreement is hereby amended as follows:

1. Article 3, Section 3.1, paragraph (a), "The Grant" is hereby deleted in its entirety and replaced by the following:

"(a) The Grant. To help achieve the Objective and Results set forth in this Agreement, USAID, pursuant to the Foreign Assistance Act of 1961, as amended, hereby grants to the GOT under the terms of this agreement, as amended, an amount not to exceed Four Hundred Seventy-One Million, Five Hundred Seventy Six Thousand, Six Hundred Seventy Six U.S. Dollars (\$471,576,676); (the "Grant").

2. Article 3, Section 3.1 paragraph (b), "Total Estimated Contribution" is hereby deleted in its entirety and replaced by the following:

"(b) Total Estimated USAID Contribution. USAID's total estimated contribution to achievement of the Objective shall be Four Hundred Seventy-One Million, Five Hundred Seventy Six Thousand, Six Hundred Seventy Six U.S. Dollars (\$471,576,676); all of which has been obligated to date and is to be provided in increments. Of this amount, Three Hundred Nineteen Million, Four Hundred Twenty One Thousand, Three Hundred Ninety U.S. Dollars (\$319,421,390) has been granted directly under this Agreement; Twenty-Five Million, Eight Hundred Twenty- Four Thousand, Seven Hundred Twenty-Nine U.S. Dollars (\$25,824,729) has been obligated by USAID/Tanzania directly into grants or contracts to provide early funding for inside residual spraying and other activities for malaria control program under the US Presidential Malaria Initiative (PMI) in Tanzania; and One Hundred Twenty-Six Million, Three Hundred Thirty Thousand, Five Hundred Fifty-Seven U.S. Dollars (\$126,330,557) has been obligated by USAID/Washington directly into grants or contracts to carry out activities in Tanzania in furtherance of the objectives under this Agreement. Subsequent increments are subject to the availability of funds to USAID for this purpose and the mutual agreement of the Parties, at the time of each subsequent increment, to proceed."

2. The Strategic Objective Grant Agreement 621-0011.01-13 Illustrative Budget contained in Annex 1 is hereby deleted in its entirety and replaced with a new "Annex 1 Illustrative Budget," which is attached hereto.

3. Except as amended herein, all other terms and conditions of the Strategic Objective Grant Agreement, as amended, remain in full force and effect in accordance with its terms.


