

**Amendment Number Thirteen to the
Strategic Objective Grant Agreement**

between

**The United Republic of Tanzania, represented by
The Ministry of Finance (“GOT”)**

and

**The United States of America, acting through
The United States Agency for International Development (“USAID”)**

1. Purpose of the Amendment

This is Amendment Number Thirteen to the Strategic Objective Agreement for SO-12, Incomes of Small Farmers Increased in Selected Commodity Sub-sectors, dated July 26, 2005 (the “Agreement”) between USAID and the GOT (the “Parties”), as amended by the Parties through Amendment Number One on September 2, 2005, Amendment Number Two on September 26, 2005, Amendment Number Three on September 13, 2006, Amendment Number Four on August 3, 2007, Amendment Number Five on August 28, 2008, Amendment Number Six on September 28, 2009, Amendment Number Seven on November 16, 2009, Amendment Number Eight on January 5, 2010, Amendment Number Nine on September 16, 2010, Amendment Number Ten on July 13, 2011, Amendment Number Eleven on September 19, 2011, and Amendment Number Twelve on February 22, 2012.

WHEREAS, the Parties hereto desire to amend the Agreement by: (1) funding the USAID grant by an increment of Seventy-Seven Million, Two Hundred Thousand United States (‘U.S’) Dollars (\$77,200,000) to support existing agriculture-related activities as part of the Feed the Future initiative; and (2) amending the Illustrative Financial Plan contained in Annex 1 of the Agreement.

2. Financing

Article 3, Section 3.1, paragraph (a), “The Grant,” is hereby deleted in its entirety and replaced by the following:

“(a) The Grant. To help achieve the Objective and Results set forth in this Agreement, USAID, pursuant to the Foreign Assistance Act of 1961, as amended, hereby grants to the GOT under the terms of this Agreement, as amended, an amount not to exceed Two Hundred Eleven Million, Seven

Hundred Ninety-Five Thousand, Five Hundred Forty-Six U.S Dollars
(\$211,795,546) (the "Grant").

Article 3, Section 3.1 paragraph (b), "Total Estimated Contribution", is hereby deleted in its entirety and replaced by the following:

"(b)(i) Total Estimated USAID Contribution. USAID's total estimated contribution to achievement of the Objective will be Two Hundred and Nine Million, Two Hundred Seventy-Three Thousand, Nine Hundred Sixty-Four U.S Dollars (\$209,273,964) (the entirety of which has been directly obligated under this Agreement.

(b)(ii) An additional amount of Two Million Five Hundred Twenty-One Thousand, Five Hundred Eighty-Two U.S. Dollars (\$2,521,582) has been obligated outside of this Agreement by USAID/Tanzania and USAID/Washington directly into grants and/or contracts, to carry out activities in Tanzania in furtherance of the objectives of this Agreement."

3. Illustrative Financial Plan

The Illustrative Financial Plan contained in Annex 1 of Strategic Objective Agreement number 621-0012.12 is hereby replaced in its entirety and a new Illustrative Financial Plan, which is attached hereto, is hereby substituted.

4. Other Terms and Conditions

Except as amended herein, all other terms and conditions of the Agreement remain in full force and effect.

IN WITNESS WHEREOF, the United States of America and the Government of the United Republic of Tanzania, each acting through its respective duly authorized representatives, have caused this Thirteenth Amendment to be made effective as of the day and year first written above.
