NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966
(80 Stat. 271; 1 U.S.C. 113)—

“ . . .the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence . . . of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof.”

The Embassy proposes, on behalf of the Government of the United States of America, that Article XV of the Agreement for Cooperation be amended by deleting "forty-one (41)" and substituting in lieu thereof "forty-three (43)".

The Embassy further proposes that, if this proposal is acceptable to the Government of the Republic of Korea, this Note together with the Ministry's affirmative Note in reply shall constitute an agreement between our two Governments that shall enter into force on the date of the Ministry's Note.
