NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966
(80 Stat. 271; 1 U.S.C. 113)—

“ . . .the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence . . . of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof.”

The Ministry of Foreign Affairs of Malaysia presents its compliments to the Embassy of the United States of America and acknowledges receipt of Embassy Note No. 389 dated 8 April 2014, regarding the Memorandum of Understanding Between the Government of the United States of America and the Government of Malaysia Concerning the Fulbright English Teaching Assistant Program, signed at Kuala Lumpur on August 8, 2012, with effect from May 3, 2011 (hereinafter referred to as the "MOU"), which reads as follows:

The Ministry has the honour to inform that the Government of Malaysia is acceptable to the proposal that the MOU be extended for an additional period of three (3) years commencing May 3, 2014 until May 3, 2017.

The Government of Malaysia further notes the Embassy's statement that it will take the proposed amendments that had been provided by the Ministry on March 21, 2014 under advisement and that the Embassy intends to respond to the Ministry's suggested changes at a later date.

The Ministry of Foreign Affairs of Malaysia avails itself of this opportunity to renew to the Embassy of the United States of America the assurances of its highest consideration.
