NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966
(80 Stat. 271; 1 U.S.C. 113)—

“ . . . the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence . . . of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof.”

The following is Amendment One to the Agreement between the Department of Defense of the United States of America as represented by the Defense Energy Support Center and the Italian Air Force as Represented by the Logistical Command – Support Services Concerning the Exchange and Reimbursement of Aviation and Ground Fuel (ITAF Agreement), which entered into force July 10, 2006.


The following change is made to the ITAF Agreement.

1. Delete the title page and replace it with the following:

2. Delete subparagraph 1.1.2. and replace it with the following:


“1.1.2. Although the Greek Ministry of Defence (GR MoD), the Turkish General Staff of the Republic of Turkey (TGS), and the French SEA are not Parties to this Agreement, they may participate as Third Parties in the balancing of accounts. The balance of one Party or a Third Party may be reconciled against the account of another Party or Third Party.”
