NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966  
(80 Stat. 271; 1 U.S.C. 113)—

“ . . . the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence . . . of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof.”

Through an exchange of notes on May 17, 2013, and August 8, 2013, between the Embassy of the United States of America and the Ministry of Foreign Affairs of the Hellenic Republic, the validity of the Agreement was extended for a period of one year, which period now expires on November 6, 2014.

The Embassy has the honor to propose on behalf of the Government of the United States that the validity of the Agreement be extended for one year from November 6, 2014 to November 6, 2015.

If the Government of the Hellenic Republic accepts this proposal, the Embassy has the further honor to propose that this note and the Ministry's affirmative note in reply shall constitute an agreement between the two Governments, which shall enter into force on the date of the Ministry's reply.

The Embassy avails itself of this opportunity to renew to the Ministry of Foreign Affairs of the Hellenic Republic the assurances of its highest consideration.

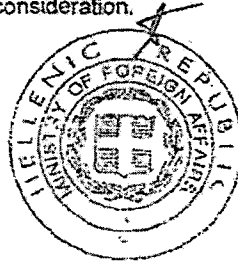

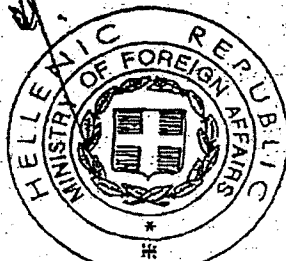
