NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966
(80 Stat. 271; 1 U.S.C. 113)—

“ . . . the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence . . . of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof.”

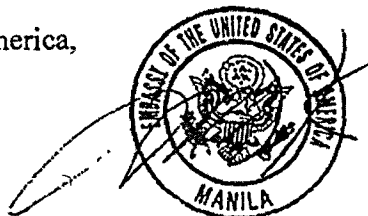

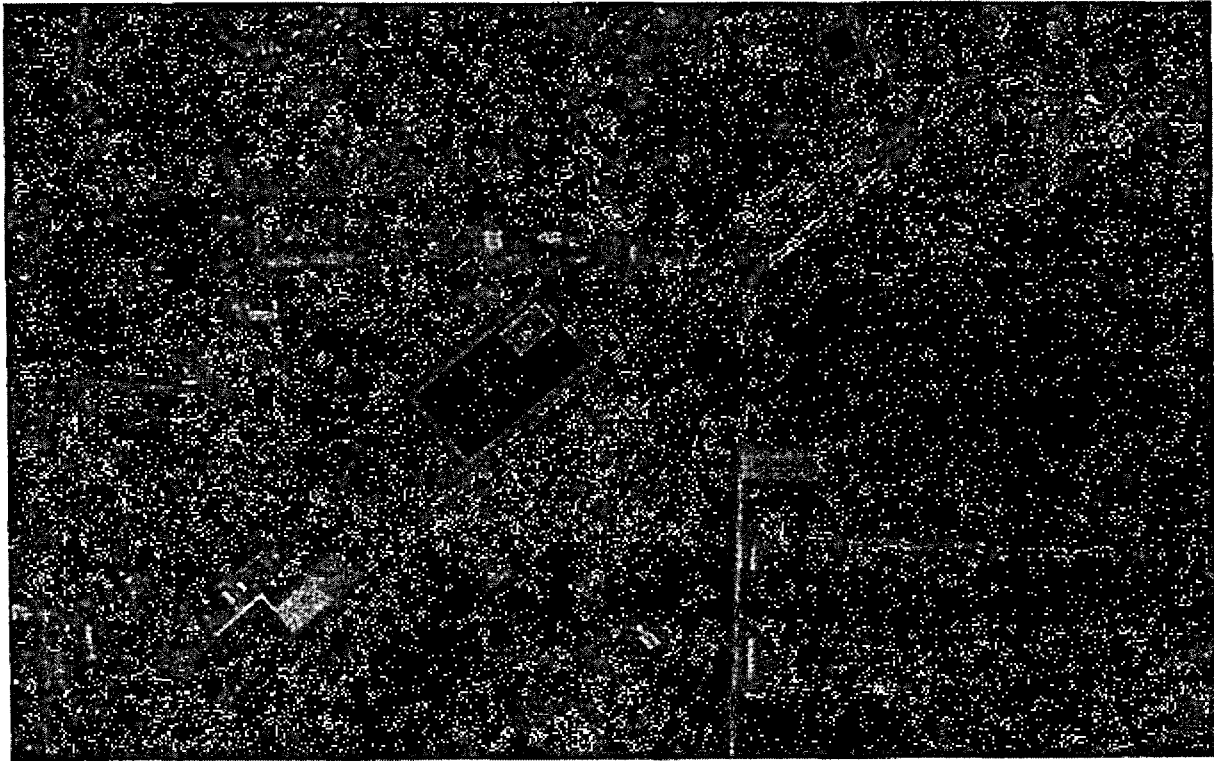
Agreed Locations

Pursuant to paragraph 4 of Article II of the Agreement Between the Government of the Republic of the Philippines and the Government of the United States of America on Enhanced Defense Cooperation (the "Agreement"), portions of the following facilities and areas are Agreed Locations that are provided by the Government of the Republic of the Philippines through the Armed Forces of the Philippines, as shown in the attached maps:

1. Fort Magsaysay, Nueva Ecija
2. Basa Air Base, Pampanga
3. Antonio Bautista Air Base, Palawan
4. Mactan-Benito Ebuen Air Base, Cebu
5. Lumbia Airfield, Cagayan De Oro

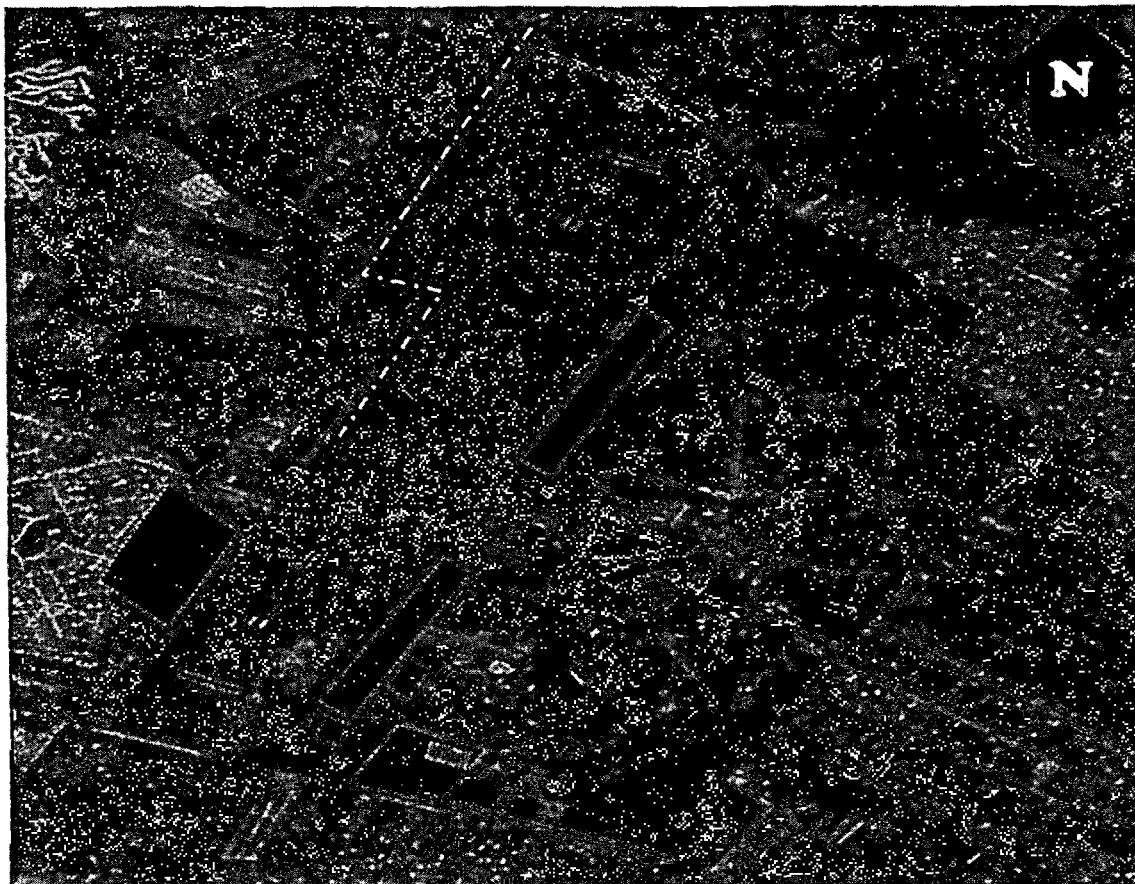
1. Fort Magsaysay, Nueva Ecija

The areas shaded in black are Agreed Locations that are provided by the Government of the Philippines through the Armed Forces of the Philippines under the Agreement.



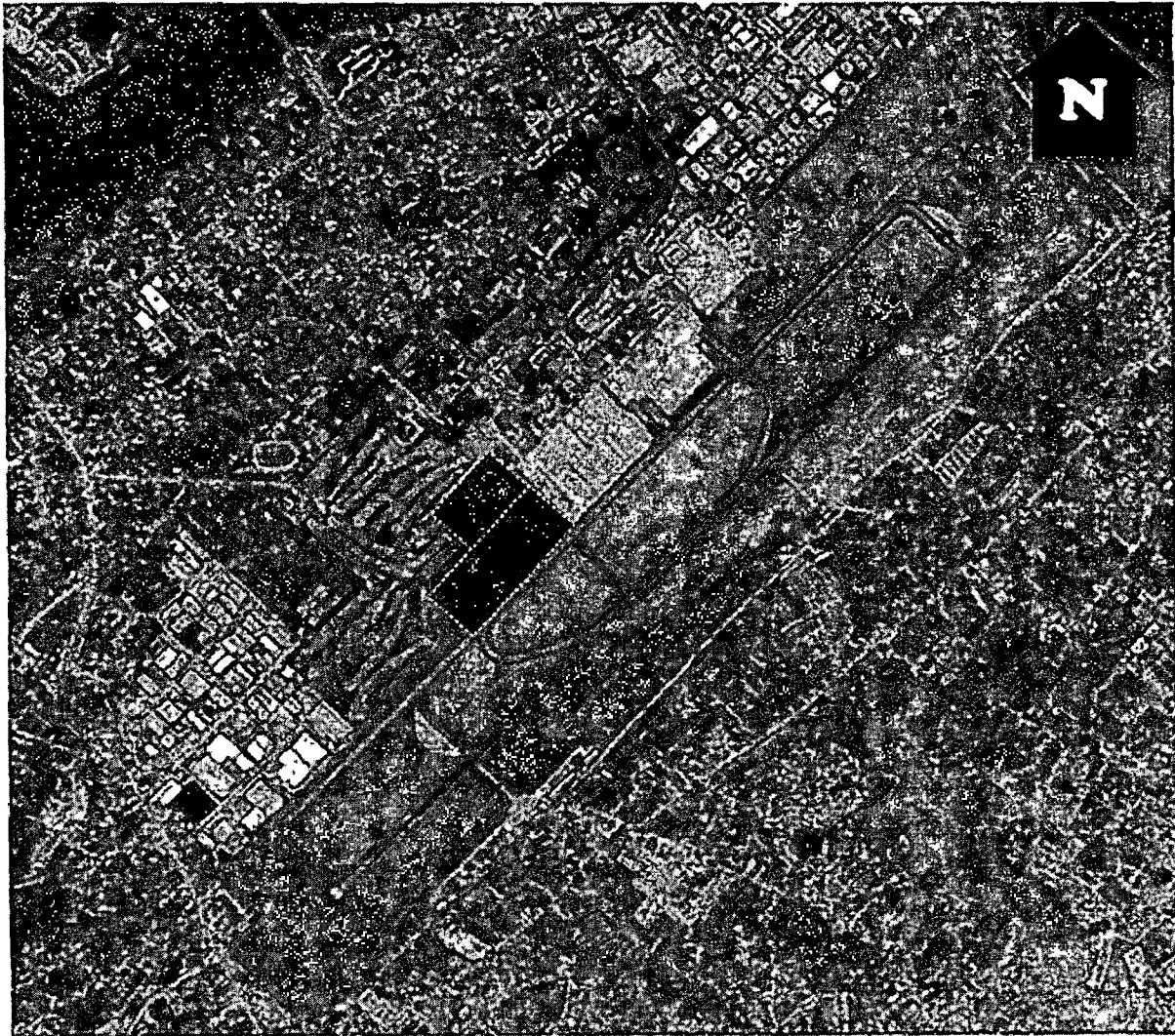
3. Antonio Bautista Air Base, Palawan

The areas shaded in black are Agreed Locations that are provided by the Government of the Philippines through the Armed Forces of the Philippines under the Agreement.



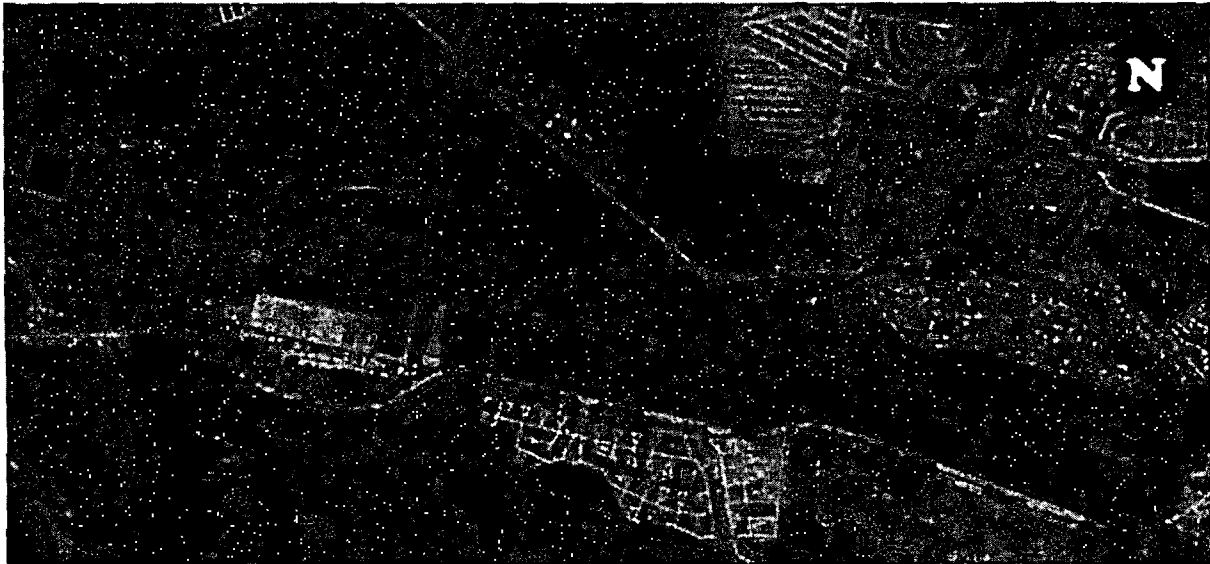
4. Mactan-Benito Ebuen Air Base, Cebu
