NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966  
(80 Stat. 271; 1 U.S.C. 113)—

“. . .the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence . . . of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof.”

The Department of State presents its compliments to the Ministry of Foreign Affairs of the Republic of Cuba and refers to the Treaty between the United States of America and the Republic of Cuba on the Delimitation of the Continental Shelf in the Eastern Gulf of Mexico beyond 200 Nautical Miles, signed on January 18, 2017 (the Treaty). On behalf of the United States of America, the Department proposes that the terms of the Treaty be applied on a provisional basis for a three-year period, beginning on January 18, 2017, and thereafter provisionally applied for successive three-year periods unless, at least two months prior to the end of a given period, a written notice to terminate provisional application at the end of that period is given by one Party to the other Party or the Parties have agreed on a different period of application on a provisional basis. In any event, the period of provisional application shall terminate when the Treaty enters into force.

If this proposal is acceptable to the Republic of Cuba, the Department of State proposes that this note and the affirmative reply from the Ministry of Foreign

**DIPLOMATIC NOTE**

Affairs of the Republic of Cuba shall constitute an Agreement between the United States and the Republic of Cuba, which shall enter into force on the date of the reply.

The Department avails itself of this opportunity to renew to the Ministry of Foreign Affairs of the Republic of Cuba the assurances of its highest consideration.

El Ministerio de Relaciones Exteriores saluda atentamente al Honorable Departamento de Estado de los Estados Unidos de América y tiene el placer de hacer referencia a la Nota No.18/08, de fecha 18 de enero del 2017 de ese Departamento, relativa al Tratado entre la República de Cuba y los Estados Unidos de América sobre la Delimitación de la Plataforma Continental en el Polígono Oriental del Golfo de México más allá de las 200 Millas Náuticas, firmado el 18 de enero del 2017 (el Tratado), en la cual se establece lo siguiente:

*“El Departamento de Estado saluda atentamente al Ministerio de Relaciones Exteriores de la República de Cuba y hace referencia al Tratado entre los Estados Unidos de América y la República de Cuba sobre la Delimitación de la Plataforma Continental en el Polígono Oriental del Golfo de México más allá de las 200 Millas Náuticas, firmado el 18 de enero el 2017 (el Tratado). El Departamento de Estado, en nombre de los Estados Unidos de América, propone que los términos del Tratado se apliquen de manera provisional durante un período de tres años, a partir del 18 de enero de 2017, y que posteriormente se sigan aplicando de manera provisional durante períodos sucesivos de tres años a menos que, por lo menos dos meses antes de que concluya un período determinado, una de las Partes notifique por escrito a la otra su decisión de terminar la aplicación provisional al final de ese período o que ambas Partes acuerden un período de aplicación provisional diferente. En cualquier caso, el período de aplicación provisional se dará por terminado cuando el Tratado entre en vigor.”*
