NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966  
(80 Stat. 271; 1 U.S.C. 113)—

“ . . . the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence . . . of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof.”

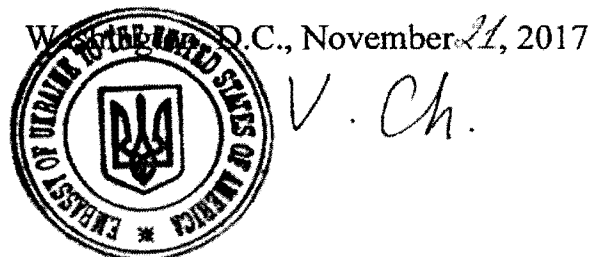

The Embassy of Ukraine to the United States of America presents its compliments to the United States Department of State and has the honor to inform that the Parliament of Ukraine has ratified the Agreement (in form of exchange of notes) to renew the Agreement between the Government of Ukraine and the Government of the United States of America on Scientific and Technological Cooperation, signed at Washington, DC, on December 4, 2006 (hereinafter referred to as the Agreement). The relevant ratification law came in force on November 10, 2017.

As stipulated by the Agreement, the Embassy hereby notifies the Department that Ukraine has completed necessary internal procedures for this Agreement to enter into force.

In this regard, the Embassy kindly asks to confirm the date when the Department receives this notice, which would be the date the Agreement comes into force for the Parties, and, accordingly, the Agreement between the Government of Ukraine and the Government of the United States of America on Scientific and Technological Cooperation shall be renewed for an additional period of five years and shall be applicable to a period of May 26, 2014 - May 25, 2019.

The Embassy of Ukraine avails itself of this opportunity to renew to the United States Department of State the assurances of its highest consideration.
