NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966
(80 Stat. 271; 1 U.S.C. 113)—

Excellency:

The Embassy of the United States of America presents its compliments to the Ministry of Foreign Affairs of the Kingdom of Thailand, and, in recognition of the mutual desire of our two governments to promote the exchange and dissemination of information through broadcasting, has the honor to propose a continuation of the successful cooperation and joint efforts in this field.

In furtherance of that objective, the Government of the United States proposes that the agreement entered into between the Government of the United States of America and the Royal Thai Government on August 11, 1965, amended through an exchange of notes on February 28, 1983, is further amended as follows:

(a) The Government of the United States of America will upgrade at its own expense the one megawatt medium wave transmitting facility referred to in paragraph 1 (a) of the 1965 agreement. This upgrade includes replacing the existing one megawatt medium wave transmitter with a new one of the same power, replacing the control room with automated equipment, installing receive-only satellite earth stations, and modifying and/or refurbishing the facility as required to effect the upgrade. The Government of the United States

of America will transfer title to the equipment installed as part of the upgrade to the Royal Thai Government when the upgrade has been completed, the date of which completion shall be promptly communicated to the Royal Thai Government. The Government of the United States of America, however, will be responsible for the continued operation and maintenance of the upgraded transmitting facility.

(b) Pursuant to Article 13 of the agreement and to the exchange of notes on March 7, 1983, the term of agreement is extended an additional twenty (20) years from the date that the new transmitter becomes operational.

(c) The Government of the United States of America will grant to the Royal Thai Government, for the exclusive use of the Public Relations Department, the receiving station referred to in paragraph 1 (b) of the 1965 agreement effective upon the date of this agreement. It is understood that all relevant provisions pertinent to the receiving station in the said agreement shall be deemed to have lapsed together with all rights arising therefrom.


(d) The Government of the United States of America will install a communications link between the Thai Ministry of Foreign Affairs in Bangkok and the above-mentioned transmitting facility. Title to and full responsibility for the communications link will transfer to the Royal Thai Government upon installation of the communications link.

(e) The Government of the United States of America will offer technical training opportunities to Voice of Free Asia studio technicians.

(f) The Government of the United States of America will make a one time, lump sum payment of US dollars 250,000 to the Royal Thai Government as compensation for future Voice of Free Asia studios. Payment will be made upon the signing of this diplomatic note amending the country-to-country agreement. Construction of new Voice of Free Asia studios shall be the sole responsibility of the Royal Thai Government.

If the foregoing proposals are agreeable to the Royal Thai Government, the Government of the United States of America proposes that this note, and the Royal Thai Government note in reply concurring in this note, shall constitute agreed amendments between the two governments of the agreement of August 11, 1963, as amended, these agreed amendments to enter into force on the date of your reply note.

The Embassy of the United States of America avails itself of this opportunity to renew to the Ministry of Foreign Affairs the assurance of its highest consideration.

(a) The Government of the United States of America will upgrade at its own expense the one megawatt medium wave transmitting facility referred to in paragraph 1 (a) of the 1965 agreement. This upgrade includes replacing the existing one megawatt medium wave transmitter with a new one of the same power, replacing the control room with automated equipment, installing receive-only satellite earth stations, and modifying and/or refurbishing the facility as required to effect the upgrade. The Government of the United States of America will transfer title to the equipment installed as part of the upgrade to the Royal Thai Government when the upgrade has been completed, the date of which completion shall be promptly communicated to the Royal Thai Government. The Government of the United States of America, however, will be responsible for the continued operation and maintenance of the upgraded transmitting facility.

(b) Pursuant to Article 13 of the agreement and to the exchange of notes on March 7, 1982, the term of agreement is extended an additional twenty (20) years from the date that the new transmitter becomes operational.

(c) The Government of the United States of America will grant to the Royal Thai Government, for the exclusive use of the Public Relations Department, the receiving station referred to in paragraph 1 (b) of the 1965 agreement effective upon the date of this agreement. It is understood that all relevant provisions pertinent to the receiving station in the said agreement shall be deemed to have lapsed together with all rights arising therefrom.

(e) The Government of the United States of America will offer technical training opportunities to Voice of Free Asia studio technicians.

(f) The Government of the United States of America will make a one time, lump sum payment of US dollars 250,000 to the Royal Thai Government as compensation for future Voice of Free Asia studios. Payment will be made upon the signing of this diplomatic note amending the country-to-country agreement. Construction of new Voice of Free Asia studios shall be the sole responsibility of the Royal Thai Government.

If the foregoing proposals are agreeable to the Royal Thai Government, the Government of the United States of America proposes that this note, and the Royal Thai Government note in reply concurring in this note, shall constitute agreed amendments between the two governments of the agreement of August 11, 1965, as amended, these agreed amendments to enter into force on the date of your reply note."



(b) As consideration for this extension of the 1965 Agreement, the Government of the United States of America shall pay the Government of the Kingdom of Thailand the total sum of \$1,500,000 over the extended duration of the agreement. The first payment in the amount of \$210,000 shall be due on November 1, 2016. The remaining six (6) payments in the amount of \$215,000 each shall become due on November 1 of each year thereafter, with the final payment made on November 1, 2022, unless the 1965 Agreement is terminated early pursuant to paragraph (c) below. Such payments are subject to the availability of appropriated funds. If the 1965 Agreement is terminated early, the final payment shall be made on November 1 of the final year of the 1965 Agreement.

(c) Notwithstanding Paragraph 13 of the exchange of diplomatic notes on August 11, 1965, if the Government of the United States of

America or the Government of the Kingdom of Thailand decides to cease operations of the one megawatt transmitting facility, either Government may terminate the 1965 Agreement by giving the other Government a minimum eighteen (18) month notice by diplomatic note.




