NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966  
(80 Stat. 271; 1 U.S.C. 113)—

“ . . .the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence . . . of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof.”

The Embassy of the United States of America presents its compliments to the Ministry of Foreign Affairs of the Islamic Republic of Pakistan, and refers it to the Agreement on Science and Technology Cooperation between the Government of the United States of America and the Government of the Islamic Republic of Pakistan signed June 25, 2003, as extended on October 23, 2013 (hereinafter referred to as “the Agreement”).

On behalf of the Government of the United States of America, the Embassy proposes to extend the Agreement for a period of five years until October 23, 2023.
