AMENDMENT NUMBER 1

ENGINEERING AND MANUFACTURING DEVELOPMENT

OF THE JOINT STRIKE FIGHTER

## **INTRODUCTION**

1. The purposes of Amendment Number 1 to the JSF EMD Framework MOU are to:
  - a. Replace the term “Engineering and Manufacturing Development” with the term “System Development and Demonstration” wherever it appears in the JSF EMD Framework MOU; and
  - b. Increase the Financial Cost Ceiling, Financial Cost Target, and the U.S. Department of Defense’s share of the Financial Cost Target.
  
2. Accordingly, the Secretary of Defense on behalf of the Department of Defense of the United States of America and the Secretary of State for Defence of the United Kingdom of Great Britain and Northern Ireland have reached the following understandings:

## AMENDMENT

The JSF EMD Framework MOU is hereby amended as follows:

1. Replace the term “Engineering and Manufacturing Development” with the term “System Development and Demonstration” wherever it appears in the JSF EMD Framework MOU.

2. Replace the abbreviation “EMD” with the abbreviation “SDD” wherever it appears in the JSF EMD Framework MOU.

### 3. SECTION I: DEFINITIONS

a. In the definition of “JSF Program”, replace the phrase “engineering and manufacturing development” with the phrase “system development and demonstration”.

### 4. SECTION V: FINANCIAL PROVISIONS

a. In Paragraph 5.1, first sentence: Replace the figure “ \$28.283” with the figure “\$33.230”.

b. In Paragraph 5.2, first sentence: Replace the figure “\$25.712” with the figure “\$30.209”.

c. In Paragraph 5.5, first sentence: Replace the figure “\$23.656” with the figure “\$28.153”.


**ENTRY INTO EFFECT**

Unless specifically amended herein, all other provisions of the JSF EMD MOU remain unchanged.


