

Agreement on the Indo-Pacific Economic Framework for Prosperity

Done: Singapore; June 6, 2024

The Agreement, in accordance with Article 11, paragraph 1 thereof, is open for signature by Australia, Brunei Darussalam, the Republic of Fiji, the Republic of India, the Republic of Indonesia, Japan, the Republic of Korea, Malaysia, New Zealand, the Republic of the Philippines, the Republic of Singapore, the Kingdom of Thailand, the United States of America, and the Socialist Republic of Viet Nam.

Entry into force: October 11, 2024

The Agreement shall enter into force 30 days after the date on which at least five of the States listed in Article 11, paragraph 1 that are party to one or more of the IPEF agreements have deposited their instruments of ratification, acceptance, or approval of this Agreement with the Depositary (Art. 11, para. 3). For each State listed in Article 11, paragraph 1 that is party to one or more of the IPEF agreements and deposits its instrument of ratification, acceptance, or approval of this Agreement with the Depositary after the condition in paragraph 3 has been met, this Agreement shall enter into force 30 days after the date on which that State deposits its instrument of ratification, acceptance, or approval with the Depositary (Art. 11, para. 4).

In accordance with Article 14, paragraph 1 of the Agreement, any State or separate customs territory that is party to one or more of the IPEF agreements may accede to this Agreement, subject to the consent of the Parties and any terms or conditions that may be decided between the Parties and the State or separate customs territory. The Agreement shall enter into force with respect to an acceding Party 30 days after the date of deposit of its instrument of accession with the Depositary. Notwithstanding paragraph 1, no State or separate customs territory may accede to this Agreement until one year after the date of entry into force of this Agreement or after the date on which this Agreement has entered into force for all States listed in Article 11, paragraph 1, whichever comes first.
