

## Indo-Pacific Economic Framework for Prosperity Agreement Relating to a Clean Economy

**Done:** Singapore; June 6, 2024

This Agreement, in accordance with Article 32, paragraph 1 thereof, is open for signature by Australia, Brunei Darussalam, the Republic of Fiji, the Republic of India, the Republic of Indonesia, Japan, the Republic of Korea, Malaysia, New Zealand, the Republic of the Philippines, the Republic of Singapore, the Kingdom of Thailand, the United States of America, and the Socialist Republic of Viet Nam.

**Entry into force:** October 11, 2024

This Agreement shall enter into force 30 days after the date on which at least five of the States listed in Article 32, paragraph 1 of the Agreement have deposited an instrument of ratification, acceptance, or approval with the Depositary. For each State listed in paragraph 1 that submits its instrument of ratification, acceptance, or approval with the Depositary after the date of the fifth deposit, the Agreement shall enter into force 30 days after the date on which that State deposits its instrument of ratification, acceptance, or approval with the Depositary.

In accordance with Article 36, paragraph 1 of the Agreement, any State or separate customs territory may accede to this Agreement, subject to the consent of the Parties and any terms or conditions that may be decided between the Parties and the State or separate customs territory. The Agreement shall enter into force with respect to an acceding Party 30 days after the date of deposit of its instrument of accession with the Depositary. Notwithstanding paragraph 1, no State or separate customs territory may accede to this Agreement until one year after the date of entry into force of the Agreement or after the date on which the Agreement has entered into force for all States listed in Article 32, paragraph 1, whichever comes first.

<sup>1</sup> The instrument of ratification of the Agreement by New Zealand includes the following declaration:

“ . . . consistent with the constitutional status of Tokelau and taking into account the commitment of the Government of New Zealand to the development of self-government for Tokelau through an act of self-determination under the Charter of the United Nations, this ratification shall not extend to Tokelau unless and until a Declaration to this effect is lodged by the Government of New Zealand with the depositary on the basis of appropriate consultation with that territory . . . ”
